The most critical resource for the success of the Solid Waste Management System is the availability of land for the creation of waste management facilities such as Mini MCF, MCF, RRF, Recycling Parks, Scientific landfills, C&D Waste Management Plants, Community Level Bio-waste Management Plants, Rendering plants, Waste to Energy plants etc. Various schemes of State and Central Government support creation of Waste Management facilities. The core component of the World-Bank supported Kerala Solid Waste Management Project (KSWMP) is also the creation of waste management facilities in the ULBs in the State. All these schemes can be successfully implemented only if sufficient land parcels are made available across the state.
