# <u>ORDER</u>

As per G.O read as 1<sup>st</sup> paper above, Government have accorded sanction for the implementation of World Bank assisted Kerala Urban Service Delivery Project (KUSDP) for providing additional financial and technical support for effective waste management, septage and sewage management, and in sanitation sector of all Urban Local Bodies(ULBs) and selected Panchayats adjoining ULBs and as per G.O read as 2<sup>nd</sup> paper above name of the Project has been changed to Kerala Solid Waste Management Project (KSWMP)

2. As per G.O. read as 3<sup>rd</sup> paper above, Government have constituted a State Project Management Unit for the implementation of the project. Following are the three components of the project:

- Institutional Development, Capacity Building and Project Management
- Grant support to ULBs for Solid Waste Management
- Development of Regional Solid Waste Management facilities

3. The total project cost of KSWMP is 300 million US Dollar, out of which 210 million US Dollar is to be financed by the Word Bank and the remaining 90 million US Dollar will be provided from State budget as State share. The establishment expenses of the Project is reimbursable from the World Bank share.

4. As per the letter read as 4<sup>th</sup> paper above, the Project Director,

KSWMP has reported that World Bank has requested to constitute a High Level Project Steering Committee (HLPSC) headed by Chief Secretary to provide periodic monitoring, strategic oversight and resolution of key issues.
