In exercise of the powers conferred by section 31A of the Travancore - Cochin Literary, Scientific and Charitable Societies Registration Act, 1955 (XII of 1955), the Government of Kerala, being of the opinion that it is necessary in the public interest so to do, hereby extend the period for submitting application for condoning delay in filing of returns, forms, annual



statements, accounts and other statements of a society on payment of a fine of five hundred rupees in respect of each year of delay in filing any or all of the same up to 30<sup>th</sup> September, 2020.

### **Explanatory Note**

(This does not form part of the order, but is intended to indicate its general purport).

The Government have implemented one time settlement scheme for the condonation of the delay in filing of returns, forms, annual Statements, accounts and other statements of a society on payment of a fine of five hundred rupees in respect of each year of delay in filing any or all of the same by amending the Travancore-Cochin Literary, Scientific and Charitable Societies Registration Act, 1955 (XII of 1955) through the Kerala Finance Act, 2015 (11 of 2015). The period for availing the benefit of the scheme was up to 31st December, 2015 initially. Later, Government as per the orders issued under G.O. (P) No. 9/2016/TD, dated 14<sup>th</sup> January, 2016, and published as S.R.O. No. 36/2016 in the Kerala Gazette Extraordinary No. 81 dated 14th January, 2016 and G. O. (P) No. 65/2016/TD, dated 16th June, 2016 and published as S.R.O. No. 425/2016 in the Kerala Gazette Extraordinary No. 1092 dated 17th June, 2016 and G.O. (P) No. 6/2017/TD dated 14th February, 2017, and published as S.R.O. No. 75/2017 in the Kerala Gazette Extraordinary No. 265 dated 14th February, 2017, G.O. (P) No. 132/2017/TD, dated 31st October, 2017 and published as S.R.O. No. 678/2017 in the Kerala Gazette Extraordinary No. 2352 dated 1st November, 2017 and G. O. (P) No. 160/2018/TD dated 8th October, 2018 and published as S.R.O. No. 702/2018 in the Kerala Gazette Extraordinary No. 2530 dated 9th October, 2018, G.O. (P) No. 139/TD, dated 15th September, 2019, published as S.R.O. No. 647/2019 in the Kerala Gazette Extraordinary No. 2183 dated 18th September, 2019 extended the period of the scheme up to 31st March, 2016, 31st December, 2016, 31st March, 2017, 31st March, 2018, 31st March, 2019 and 31st March, 2020 respectively. Now, the Government have decided to extend the period of the scheme up to 30<sup>th</sup> September, 2020 on public interest.

The order is intended to achieve the above object.
