S. R. O. No. 246/2017.—In exercise of the powers conferred by sub-clause (b) of sub-rule (1) of rule 98 of the Kerala Minor Mineral Concession Rules, 2015, the Government of Kerala hereby appoints the Secretary to Government, Industries Department as the Final Appellate Authority to exercise the powers and perform the functions under the said rules and consequently make the following amendment to the notification issued under G.O. (P) No. 13/2016/ID dated 23rd May, 2016 and published as S.R.O. No. 389/2016 in the Kerala Gazette Extraordinary No. 998 dated 27th May, 2016, namely:—

AMENDMENT

In the Schedule to the said notification, for the entries against Final Appellate Authority in column 2, for the words "Principal Secretary to Government", the words "Secretary to Government" shall be substituted.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government have appointed officers of Industries Department in Government as the Appellate Authority and Final Appellate Authority to exercise the powers and perform the functions as defined in sub-clauses (a) and (b) of sub-rule (1) of rule 98 of the Kerala Minor Mineral Concession Rules, 2015 as per notification issued under G.O. (P) No. 13/2016/ID dated 23rd May, 2016 and published as S.R.O. No. 389/2016 in the Kerala Gazette Extraordinary No. 998 dated 27th May, 2016. Now, the Government have decided to appoint the Secretary to Government, Industries Department as the Final Appellate Authority to exercise the powers and perform the functions as per the said Rules.

The notification is intended to achieve the above object.
