JUDGMENT

The petitioners presented a partition deed for registration treating it as a partition among the family members and paid stamp duty and registration fee accordingly. The property originally belonged to Theyyan and Ammalu. The parties to the deed are grandchildren, daughter of Theyyan and Ammalu and the widows of predeceased children of the aforesaid Theyyan and Ammalu. In view of the fact that the parties are not forming part of natural family unit, the Registrar refused to register on a lesser stamp duty. This is how the petitioners have approached this Court.

2. The question is whether they can be treated as a family under Section 2(fb) of the Kerala Stamp Act. Section 2(fb) defines 'family' as "father, mother, grandfather, grandmother, husband, wife, son, adopted son, daughter, adopted daughter, grandchildren, brother and sister". It does not include a widow. However, entry in Sl. No.42(a) of the Schedule after amendment, family unit would include legal heirs of the deceased family member, if any. The widow also is a legal heir of the deceased family member. Such being the case, I am of the view that in the light of Section 2(fb) and inclusion of legal heirs of deceased family member by way of entry in Sl.No.42(a) of the Schedule, the petitioners are entitled for registration, treating it as a partition among the family members. There shall

be a direction accordingly, to register the document treating it as a partition among the family members.

The writ petition is disposed of as above.
