# JUDGMENT

Petitioner presented an instrument for registration. Citing pendency of a Civil Suit instituted by the second respondent, Sub Registrar refused to register the document.

2. As seen from the Suit, Civil Suit was only for an injunction. Pendency of the Civil Suit cannot be a reason at all, to decline the request of registration. In the absence of Civil Court passing an order restraining the petitioner from executing deed, registering authority cannot refused to register the deed. However, this will be subject to the outcome of such suit with regard to the right or interest over the property. Subject to the outcome of the Civil Suit, the instrument presented by the petitioner shall be registered in accordance with law.

The Writ Petition is disposed of.
