## JUDGMENT

The petitioner approached this Court seeking the following reliefs:

- i) Issue a writ of mandamus or any other appropriate writ, direction or order commanding the first respondent to register the documents presented before him for registration in terms of 'The Registration Act, 1908', without insisting for production of R.O.R.
- ii) In the alternative, issue a writ of mandamus or any other appropriate writ, direction or order commanding the fourth respondent to issue thandaper account requested for in Ext.P25 application, within a time frame.
- 2. In the light of the judgment of this Court in **Synudheen** vs. **State of Kerala** (2013 (1) KLT 221), in the absence of amendment to Registration Rules, the parties cannot be compelled to obtain Record of Right as a precondition for registration.

Therefore, without insisting for Record of Right, the document presented by the petitioner shall be registered in accordance with law.

This writ petition is disposed of as above.
